Today, the movement runs it’s weekly support meetings across 25+ location in India and hence, it won’t be wrong to say that we actually work towards #Hope4Men, day in day out. SIF One, 8882498498, Helpline for Men gets about 6000 calls every month. This itself talks about the magnitude of the problem India has. Since the government, authorities, law makers are turning a blind eye, the candle of #Hope4Men Seminars by SIF Movement, indeed takes the role completely”.
