EDUCATION

- Free Primary Education for all, irrespective of Gender across all Government Schools
- Free Laptop to top 10% of Primary & Secondary Education students [based on Scholarship test & not Gender]
- To make all the Educational Policies, subsidies, etc. Gender Agnostic and not discriminating children based on Gender

HEALTH

- Equal Budget allocation on awareness and medical needs of those suffering with Prostate / Testicular Cancer
- Name of Father & Mother to be in Birth Certificate
- PNDT & MTP Act to include Father's Consent as of Mother
- Complete ban on any maternity incentive based on gender of the child.

Hence, we strongly recommend following to the Political Parties of India:

- 1. NOT TO IGNORE THE MALE VOTE BANK**
- 2. To include above non-negotiable demands as their promises in the Party Manifesto**
- 3. To stop using Gender Based appeasement**
- 4. To act on these promises, once in power**
