**CAT notice to AIIMS on plea against 80% seats for women in nursing posts**

Male Hatred or Misandry in India was again seen at fore, when on 5<sup>th</sup> August 2020, AIIMS advertised Nursing Officer Recruitment Common Eligibility Test (NORCET) where **80% Seats are reserved for Females and 20% for Males**. AIIMS, Central

Institute Body (CIB) held on 27<sup>th</sup> July 2019 stated “*The CIB discussed on the issue of appropriateness and requirement of female nursing staff in a number of departments/ specialized wards vis-à-vis patient comfort and care.*”

Misandric CIB presumed that reserving 80% posts for women is **appropriate and required for patient comfort and care**. Not only decision taken is **misandrist** to its core but highly demeaning to men as it presumes that men are not appropriate for comfort and care of patients. Additionally, it is divisive and discriminatory as it differentiates between the two genders; it is insulting to present and past male nurses demeaning them as inferior to the female nurses. It is provocative by virtue of hurting the feelings of almost half of the population; it demonstrates double standards of the government where, on one hand, it burdens men with the responsibilities of protector and provider of the family and on the other hand, deprives men of job opportunities in name of Feminism; and last but not the least it violates fundamental right of male nurses to employment.

This decision witnessed several backlash from Nurse Associations. But then, when it comes to discrimination against men, everyone is happy to ignore it.

**In bid to hire more women drivers, Delhi Transport Corporation to ease rules**  
The rules state that a driver must have a licence to drive a HMV and have three years of experience driving a bus.

In another instance of women appeasement, utter disregard to passenger’s safety was committed in 2016 by Delhi Transport Corporation (DTC) when it relaxed rules for hiring women drivers. So,

Feminism once again won over the life and survival of Delhites on Roads, either as passengers or as other commuters using the same Road.

Gender discrimination and appeasement are not limited to jobs but begin during education itself. While Educational Institutes use Name of the Country but cater to appeasement of one gender only. “Indian Institute of Management (IIM) Calcutta” started granting extra points to female students in the name of gender diversity as far back as in 2013. Grant of extra points to 1 gender without merit was to just get more female on the campus, even if non-deserving. This so-called gender diversity (a.k.a. Discrimination) is now in majority of IIMs and used to dole-out extra points to female candidates at the cost of male candidates in most discriminatory manner. Merit and higher standards of selecting best talent have clearly been given a pass in the name of gender appeasement.

Similarly, Indian Institute of Technology (IITs) in 2018 implemented a quota of supernumerary (over and above actual intake) seats for women. Justification quoted was again the same gender imbalance hoax. It meant, female candidate could not make it to the IIT through general quota seat, she has a chance to make it through the new dedicated quota

seat. So, even in IITs, merit was given a pass and push for female candidates to enter, irrespective if they deserve it or not vis-à-vis male candidates.

IIT, just not penalized the male gender, but their parents too, who pay the Entrance Examination fees. IITs allow female student to pay half of what a male student must pay to appear for prestigious IIT-JEE examination. This is the kind of discrimination which is of most disastrous consequences because at the heart of it is penalizing a parent who had boys on how dare they give birth to a boy. Even If a male student is from poor background, he pays double of what a rich background female student is paying as application fee.

All the above examples point to Feminism having taken a deep root in our society and like a cancer eating it slowly to annihilate it eventually. Gender discrimination is being sold as gender diversity which is nothing but a smart marketing gimmick every country man must be able to see though. Some urgent and immediate steps must be taken to save the social fabric of society. Recently, Govt. of Paris showed the way to entire world how Feminism must be dealt with an iron hand. Paris City Hall was fined €90,000 (over Rs 80 lakh) for appointing women in 69% management positions in 2018 which violated a 2013 rule stipulating that one gender should not account for more than 60% nominations to management positions. Govt. of Paris did not tolerate the rule being broken by feminists of Paris City Hall, for the appeasement of women at the cost of men.

MWT and SFF demand following corrective steps to stop any kind of discrimination and save society from a cancer, Feminism is:

1. All Misandric policies in all Public/Private institutes must be immediately withdrawn AND fined;
2. Amend laws, policies and procedures to ensure that merit alone would be the criterion for all future selections;
3. Any loss to the exchequer because of discriminatory policies so far must be recovered from institutes (public/private).
