

Sub: - **Request for information u/s 6 & 7 of RTI Act 2005**

Sir,

I humbly request you to furnish me with the following details under section 6 & 7 of the RTI act:

- 1) Kindly advise if the list of Streedhan, as submitted is a valid list as per the Rule 2 of Dowry Prohibition Act.**

If rejected/exempted, please provide the reason/s mentioning section under RTI Act

- 2) Kindly advise in YES/NO format, if was asked by the IO to produce valid bills of all items mentioned in the Streedhan List (including Gold ornaments).**

If rejected/exempted, please provide the reason/s mentioning section under RTI Act

- 3) Kindly advise in YES/NO format if Rule 2 of the Dowry Prohibition (Maintenance of List of Presents to the Bride and Bridegroom) Rules 1985; was observed by the IO in this case.**

If rejected/exempted, please provide the reason/s mentioning section under RTI Act

- 4) If the answer to the above question is yes, please advise if the list complied with the provisions of the Dowry Prohibition Rules, 1985 while accepting complaint from**

If rejected/exempted, please provide the reason/s mentioning section under RTI Act

- 5) Kindly provide the attested/certified copy of supportive bills/VAT of all the items mentioned in the Streedhan, including the Golden ornaments.**

If rejected/exempted, please provide the reason/s mentioning section under RTI Act

- 6) If the answer to point (c) is "Yes", please provide the following:**

- a. Attested/certified copy of the Flow of Money, Bank Statements,**
- b. List of gift received from relatives along with their name and address,**

- c. Shop Bills/VAT pertaining to the purchase of these items (including golden ornaments) by the complainant and her family members.**

If rejected/exempted, please provide the reason/s mentioning section under RTI Act

- 7) As per the court judgement, investigation is required to be conducted on the Streedhan submitted by the complainant. In this context, kindly provide the answers to the following queries:**

- a. Does the IO propose to do any investigation to validate the authenticity of the Streedhan list and the bills provided**
- b. If NO, what is the reason?**
- c. If YES, kindly share the outcome of the investigation.**

If rejected/exempted, please provide the reason/s mentioning section under RTI Act

- 8) Kindly advise the various provisions/actions that can be taken by the Government if the list of Streedhan submitted by the complainant; was accepted due to failure/negligence of compliance of any Act/Judgments of Union of India.**

If rejected/exempted, please provide the reason/s mentioning section under RTI Act
