ABSTRACT:

Statistics have pointed out that on average the incidences of completed suicides are vastly higher among males than females in all age groups around the world. For every 5 suicides around the world 4 of them are distinctively men with a ratio of 4:1. This project is an amalgamation of some of the cases of male suicide in the recent years, it aims to open a window to the burdening question of why are men committing more suicides?

Family cremates Karnal suicide victim after 5 days of protest

Date: Feb 14, 2014

Marital status: Married

Age: 18

Reason: False allegation and legal prosecutions from wife and family

Location: Haryana

KARNAL: Family of Akhil Chauhan, a resident of Karnal who committed suicide on February 1, cremated his body on Thursday after the arrest of his wife Priya Verma and father-in-law Vijay Verma. Akhil had consumed poison after being allegedly harassed by local police at the instance of his in-laws and wife.

Akhil's family and relatives had protested for five days, seeking the arrest of persons allegedly involved in abetting his suicide. The victim's last rites were performed in the morning amid tight police security at Shivpuri cremation ground in Model Town.

Earlier, both Priya and Vijay had surrendered before the chief judicial magistrate (CJM) after the court issued arrest warrants against them. CJM Amit Garg sent Priya and Vijay to police remand for two and four days respectively.

On the basis of a suicide note recovered from Akhil's pocket, police registered a case against nine persons, including his wife, her parents, their advocate and a relative apart from three cops - inspector Manoj Verma, SHO of civil lines police station Ajit Ram, and assistant sub-inspector (ASI) Ram Bhajan.

On Wednesday, Vijay, an employee of the [Haryana State Agricultural Marketing Board](#) (HSAMB), was placed under suspension by his organization for his alleged involvement in forcing Akhil to commit suicide. Inspector Verma and ASI Bhajan were suspended for their alleged in the suicide of Akhil.

Headline:

102-year-old man commits suicide in Kolkata

Date: Jul 16, 2015,

Marital status: Married

Age: 102

Reason: Family problems and isolation, Depression

Location: West Bengal

HOWRAH: Tired of a life of neglect by his own daughter and grandson coupled with frustration with an era so much in contrast with his times, 102-year-old Kalipada Ray is suspected to have burnt himself to death in his Howrah home on Wednesday morning. The old man's maid Sabitri Biswas, who has been his sole caregiver for several years, said Kalipada was depressed over his multiple old age-related ailments and complete detachment of his family with him. Research papers by geriatric experts show forced seclusion is a potential cause of suicide among aged men, especially those as old as Kalipada.

On Wednesday morning, the old man sent Sabitri out to get him some food. When she returned half an hour later, Sabitri got no response from Kalipada in spite of knocking on his door several times. Sabitri immediately informed the old man's grandson Kaushik on the ground floor of the two-storied house in Howrah's Jagacha. Neighbours too were informed and Jagacha police station was called. Police arrived, broke open Kalipada's door and found him lying with burns in the kitchen. He was taken to Howrah hospital where doctors declared him dead on arrival. Police searched the house but found no suicide note.

Though police suspect suicide, neighbours wondered how the old man who needed support to move and remained seated or in bed most of the time could manage to close the door and walk from his living room to the kitchen.

On interrogating Sabitri and a widower for long, the former senior Eastern Railway officer lived a secluded life on the first floor of his own two-storied house in the Gharamipara locality of Howrah's Jagacha for several decades now. His grandson Kaushik, a clerk in Howrah court, lived on the ground floor. A bachelor, the 39-year-old grandson preferred to live alone on the ground floor leaving his grandfather in

After interrogating Kaushik and his mother, police said mother and son apparently wanted Kalipada's valuable property and his large pool of savings. This had also left Kalipada deeply disturbed. Police also learnt that Kaushik allegedly did not allow neighbours to meet his grandfather. Besides this forced seclusion, police also found a diary the old man maintained. In this diary, Kalipada had penned his frustration with the present era which he described as completely mechanical and heartless.

"Our primary suspicion is suicide though we are waiting for the autopsy report," said Howrah City Police assistant commissioner of police Biswachand Thakur said.

Two commit suicide in separate incidents

NAGPUR: Two men committed [suicide](#) in different incidents on Tuesday evening. The reason for both the men, 38-year-old Prashant Sahebrao Patil and 75-year-old Narayan Chabuji Bhoyar, taking the extreme step by hanging themselves is yet to be traced by the police.

Bhoyar, a resident of Hari Om Society, Wadi, committed suicide by hanging himself to an iron rod at his home at around 5pm. "The family couldn't give any reason for the suicide and no note has been found too," said PSI SU Bhaskar.

Bhoyar's wife is no more and he lived with his son. Police said, "He lived in a room behind his son's. He had taken some goats they rear for grazing in the afternoon. His daughter-in-law discovered the body when she went to his room with evening snacks and tea." A case of accidental death has been registered at [Wadi police station](#).

In the case of Patil too, the [MIDC police](#) could not find any suicide note or reason. "Nobody in the family is in a state to say anything," said PSI MV Wankhede. Patil's body was found by his uncle who had come to visit their Rajgruha Nagar residence.

"Patil lives on the upper floor while his mother stays on the lower floor. After meeting his mother, Patil's uncle came to meet him and found the door bolted from inside. He saw the body hanging from the ceiling fan through a window," said Wankhede.

NEW DELHI: A 26-year-old PhD scholar of Delhi's Jawaharlal Nehru University today allegedly committed [suicide](#) by hanging himself at his rented accommodation in south Delhi's Ber Sarai area this morning.

The deceased, Dushyant, a native of Bareilly in UP, left a suicide note in which he mentioned some personal problems, including family issues and his relationship with a woman, police said.

Dushyant lived in the first floor of a building in Ber Sarai which had around nine single rooms, all rented to students and working men. He allegedly hanged himself from the ceiling fan, the official said.

"We received the call in the morning and rushed a team. A suicide note was found in the room. We have informed his family and initiated an inquest into the matter," DCP (South) Prem Nath said.

The police said that the boy could have committed suicide as an act of revolt against his teachers, who reprimanded him for consistently bunking classes. A suicide note mentioning this was recovered from his bag, which was found abandoned in the school. On Tuesday, after being scolded by a teacher, he left the school, leaving his bag behind. TNN

In the first incident, [Nikunj Sutariya](#) (25) hanged himself from the ceiling of his room at his house in Patelnagar-2 on 40-ft Road in Omnagar, Mavdi Plot. "Nikunj's wife had left him and gone to live with her parents after a fight with him. Nikunj had been depressed for quite some time, owing to which he took the drastic step. He had used a blanket to hang himself," an investigating official said.

In the second incident, Sanjay Keraliya (28) hanged himself from the ceiling of his house in [Sitaram Park](#) on Morbi Road after he had an altercation with his wife on Friday night.

NEW DELHI: A 26-year-old man committed [suicide](#) at the servants [quarters](#) of a [church](#) in [Khan Market](#), where he stayed with his family.

Police said that Ruban's mother said that he was being pressurised by his friends to return some money he had borrowed from them, due to which he was under depression. Ruban used to drive taxi in the area.

Police said that Ruban's body was found hanging from a ceiling fan on Friday evening. No suicide note was found at the spot. Ruban's mother raised an alarm after he didn't respond to her knock, when she was asking him to come for dinner. She informed the pastor and some other employees of the church, who managed to break open the door and found his body.

Ruban's family members have been staying at the church premises for a few generations. He is survived by his wife and two minor sons.

Police are awaiting the postmortem report and investigating the case from all possible angles. Cops have seized Ruban's phone and some documents found in his wallet and are trying to contact his friends.

Two men commit suicide in Shahjahanpur

Shahjahanpur: Two men allegedly committed suicide in separate incidents in Shahjahanpur district on Tuesday night. In Jalalabad block, a 35-year-old man shot himself with his licensed gun while a 27-year-old man hanged himself to death with a rope in a village of Sindhauli block on Wednesday morning.

According to police, Laljeet alias Pappu had a tiff with his wife Tarawati on Tuesday night in Sindhauli area. Thereafter, he left the house and didn't return. His body was found hanging from a tree on Wednesday. The body has been sent for postmortem. The autopsy report is awaited though according to police the circumstances suggest that he committed suicide.

The second suicide case was reported from Kanoongoyan colony of Jalalabad town on Tuesday night where one Vineet Pandey shot himself in his head during a birthday party. Vineet was immediately rushed to the hospital but doctors declared him dead. Vineet was reportedly under the influence of alcohol. His wife, Rachna Pandey told police that Vineet was upset over the fact that the couple didn't have kids in 10 years of their marriage. He had even attempted to commit suicide a fortnight ago by consuming poison but was saved then. Vineet's body was handed over to his wife after postmortem while the pistol was seized.

SHO of Jalalabad police station Sharad Malik said, "It was a case of suicide as the deceased shot himself in front a several guests during a birthday party. We have completed the investigation and closed this case after recording the statement of family members and eyewitnesses."

Dubai: A 35-year-old Indian man in the UAE has allegedly committed suicide by hanging himself from a ceiling fan at his house in the northern Ras Al Khaimah city, a media report said today.

Rinoj Raveendran, from Kerala who was working as an accountant in the Al Ghail industrial area, was found dead by his roommate on Saturday evening.

Prasad Sreedharan, a social worker affiliated with a medical committee recently constituted by the Consulate General of India in Dubai, told the Khaleej Times that the suicide note found on Raveendran's phone states that he committed suicide due to "health issues".

An investigation is underway to ascertain the reason behind the victim's apparent suicide, police said. "A report on the same shall be issued later on," they said.

He apparently removed the fan from the ceiling of his room, which he was sharing with another fellow worker. His roommate found him hanging when he returned on Saturday evening, Sreedharan said.

Chhattisgarh: Man accused of raping, trafficking minor girl commits suicide

Reason: Fall in social position, legal prosecution

RAIPUR: In a major twist, one of the ten accused booked for rape and forced prostitution on a minor girl in Mungeli district, has committed suicide at Chakarbhata railway station in [Bilaspur](#) on Sunday morning. Police said there was no suicide note recovered from the spot.

Mungeli police had on Thursday booked ten persons in connection with rape with minor girl on pretext of marriage by a man who further pushed her into flesh trade for two years and kept her in confinement.

Nine others including the deceased were involved with him and used to repeatedly rape her and never hesitated to serve her to other men. Police, however, refuse to divulge much information stating it to be a sensitive case involving minor girl while there were inputs about involvement of high-profile people in the case.

"The body of Dharmendra Bharti was found on the tracks at Chakarbhata railway station on Sunday morning. He was one among the ten accused in rape of 17-year-old girl who pushed her into sex trade for two years in neighbouring Mungeli district. There was no suicide note recovered and the exact reason is though not ascertained, but he took the extreme step after two days of the FIR lodged against him," Bilaspur superintendent of police Prashant Agrawal told TOI.

The SP indicated that Dharmendra alias Dharmu used to work as pimp to provide girls for flesh trade, though he used to run a grocery shop. Since the matter came to the light, Dharmendra was hiding at his sister's place at Chakarbhata. He was a resident of Takhatpur.

Insiders said that there was suspicion Dharmendra might have not committed suicide rather he was killed as there weren't many injury marks on his body. Police haven't revealed much information indicating involvement of influential people and politicians.

CHENNAI: Police on Tuesday arrested four men who dumped the body of a 45-year-old man in [bushes](#) near [Chennai airport](#).

Police on Friday night recovered the body of Anandan, who had committed [suicide](#) in a [lodge](#) at Anakaputhur. The man's body was dumped near the airport by lodge manager and three staff members after they found him dead by consuming poison-laced liquor. Police arrested the lodge manager and three others for hiding facts and trying to distort evidence.

Anandan, a resident of Kodungaiyur, had been staying in a lodge Anakaputhur after quarrel with his wife.

The lodge staff, who found him dead in his room, decided to dump the body somewhere since they feared they would be in trouble. They hired an autorickshaw and took the body to near secluded place near the airport where they dumped it.

The police, who checked of footages from CCTV cameras in the area, noticed an autorickshaw. They traced the suspects with the help of the autorickshaw registration number.

Postmortem report said the man had committed suicide by consuming poison.

The suspects were released on bail.

UP: Two men commit suicide after their wives refused to return home on Karwa Chauth

Date: October 18, 2019

Marital status: Married

Age: 22, 35

Reason: Infidelity, Love Affair of the wife

Location: Lucknow

The first case was reported in Gopalpur village under Sahawar police jurisdiction in [Kasganj district](#), where a 35-year-old man hanged himself from a tree a day before Karwa Chauth. According to police, the victim, identified as Sugad Singh, was depressed after his wife refused to return home.

"Sugad was a daily wage labourer working in Noida. Two months back he returned home and found that his wife Rajni left his home and had started living with her paramour Jaypal in Etah district. After failing to convince his wife to return for Karwa Chauth, the victim hanged himself," said Ganesh Chauhan, station house officer of Sahawar.

"The couple were married for several years. No written complaint has been received yet," added SHO.

In neighbouring district Etah, a 22-year-old man allegedly hanged himself from ceiling of his room on Thursday night, after his estranged wife refused to return home for Karwa Chauth.

Married for seven months with Kamyaganj, Farrukhabad district-based woman Poonam, the victim Vidyaram hailed from Amroli Ratanpur village of Aliganj police jurisdiction.

According to the victim's elder sister Rekha, "After marriage the couple stayed together only for a month and later Poonam left him alone. Vidyaram hanged himself while talking to Poonam on phone, requesting her to return home for Karwa Chauth."

Ajay Bhadauria, circle officer of Aliganj said, "A probe is on to ascertain why Vidyaram committed suicide. Till now, no written complaint has been received from the victim's relative."

Two Kerala men commit suicide in Covid-19 isolation ward

THIRUVANANTHAPURAM: Two suspected cases of [suicides](#) were reported at the deluxe pay ward of Thiruvananthapuram [Government Medical College Hospital](#) (MCH) which functions as an isolation ward for suspected or confirmed cases of Covid-19. One was a 33-year-old man, who was brought to the hospital as a [Covid-19](#) patient and recovered recently, and the other a 38-year-old man, who was brought here on Tuesday night and was awaiting his Covid-19 test results.

The recovered Covid-19 patient from Anadu had run away from the hospital on Tuesday, the day he was to be discharged. He was caught from near his home and brought back. A nurse who brought him the prescription for medicines to be taken after discharge found him hanging around 11.30am on Wednesday. He was rushed to a critical care unit, but could not be saved.

Murukesan, the second person who allegedly killed himself, was found hanging in the evening in his isolation ward. He was from Nedumangad and was brought to MCH on Tuesday night with symptoms of Covid-19 and was under [observation](#).

Health minister KK Shailaja asked the department's principal secretary to conduct a probe and file a report on both the suicides. Chief minister Pinarayi Vijayan said the two suicides of patients at MCH, under Covid-19 observation, was most unfortunate.

"It cannot be said that it has occurred due to laxity from the part of the hospital authorities. However, an inquiry is being done," he said.

2 Friends Found Hanging From Same Rope In Bengal, Cops Suspect Suicide

Bodies of Rathin Roy, 28, and Anwar Hossain, 25, were found on Wednesday evening in Kaliganj area in the district's Rajganj town, police said.

Hossain was to get married on Thursday and Roy got married a month back, their families said.

The families said they cannot understand why the two friends committed suicide.

Police said a bottle of poison has been recovered from near the tree where the bodies were found.

The bodies have been sent for post-mortem examination and further investigations are underway, an official of the Rajganj police station said.

COIMBATORE: A driver working for a private hospital at [Singanallur](#), who got married last week, committed suicide by hanging in his residence on Sunday.

"He had married a nurse working in the hospital on July 7. After she married Ganeshan, her former boyfriend, a [Namakkal](#) native, committed suicide on Friday. The woman, who came to know about the death, became distressed and told Ganeshan about the incident. A depressed Ganeshan committed suicide by hanging on Sunday evening," a police officer said.

The Singanallur police registered a case and sent the body to the [Coimbatore Medical College](#) and Hospital for postmortem.

It was handed over to the family on Monday afternoon.

PHAGWARA: A 23-year-old man allegedly committed suicide by hanging himself at his aunt's house in Hadiabad here on Wednesday, police said.

Satnampura police station assistant sub-inspector(ASI) Harjinder Singh said, "The dead has been identified as Harpreet Singh of Mukliana village in [Hoshiarpur](#) district."

Harpreet was living at the house of his aunt in the Dr Ambedkar chowk area of Hadiabad.

"His aunt had gone out and when she returned home after half an hour, she found Harpreet hanging from a girder of a room," said the ASI.

The police officer said, "The victim was suffering from a chronic ailment and was in a state of depression, which seemed to have driven him to take the extreme step."

The body was handed over to family members after a post-mortem examination.

AURANGABAD: Two young men ended their lives, fearing [social stigma](#) on being falsely accused of molestation, in Sillod rural of Aurangabad district on Tuesday.

Police said that three people, including a woman, have been [arrested](#) for abetment to [suicide](#)

. After being produced before the court, have been remanded in two-day police custody.

The deceased [youths](#) have been identified as [Yogesh Khiste](#) (23) and Dnyaneshwar Shirsath (20). Both were employed as watchmen at a godown. The arrested accused are Shaikh Moin, a clerk in a local school, Shaikh Mushtaq, a private employee, and their female accomplice.

Sillod rural police station's assistant inspector Pralhad Munde told TOI, "The probe has revealed that the victims had objected to the accused frequenting a deserted place near a farm on Sunday evening." As the accused trio was fleeing, their bike skid off the road, and they sustained some injuries. The woman accused then started alleging that the watchmen had tried to molest her. She along with her two friends threatened Khiste and Shirsath that they would lodging a complaint of molestation against them.

Fearing that they will be framed in a false case of molestation, the two youths went to the godown. There they wrote a suicide note and posted it as their WhatsApp status, blaming the trio of threatening to frame them in a false case. They added they cannot see their parents being embarrassed and feared social stigma due to molestation charges. Then they hanged themselves.

Ananda Pawar, one of their acquaintances, saw the WhatsApp status on Tuesday morning and tried calling the two young watchmen, but in vain. Pawar then rushed to the godown, only to find their bodies. Soon the police were informed and bodies were taken to hospital, where they were declared brought dead. A case of abetment to suicide has been registered against the accused trio.

Barnala: A fortnight after Punjab State Women Commission (PSWC) chairperson Manisha Gulati visited the family of a man who committed suicide as his wife took money from his family for settling in Canada and then dumped him, police on Wednesday registered case against the woman.

Beant Kaur of Khudi Kalan village in Barnala, presently living in Canada, has been booked for cheating. PSWC chairperson had been taking keen interest in the episode and uploaded a video clip on Monday, alleging that no case had been registered despite her recommendation and repeatedly calling Barnala police.

Many cases of frauds by women who have cleared IELTS, by making the groom's family spend money to help them settle abroad and then ditch them, came to fore when Gulati visited the family of farmer Balwinder Singh at Dhanaula in Barnala district on July 13. Balwinder's son Lovepreet Singh (24) committed suicide on June 23. Gulati was confronted by dozens of men or their parents, who had similar stories of getting defrauded.

Balwinder, who owns five acres at Kotha Gobindpura village near Dhanaula, wanted son Lovepreet to settle in Canada. Balwinder claimed that his family spent nearly Rs 24 lakh in sending Beant to Canada. The girl left for Ontario on August 19, 2018, to pursue a computer course. She returned on August 5, 2019, to solemnise marriage with Lovepreet, and it was done on August 7. She again left for Canada on August 17, 2019, promising to call Lovepreet soon. However, she started avoiding him on reaching Canada.

Gulati had written a letter to Canadian Prime Minister Justin Trudeau, raising the issue of exploitation of Punjabi youth in the name of Canadian citizenship and urged the PM to take rapid and stringent actions to stop exploitation and bring culprits to justice. She also wrote that a mechanism needs to be operationalised to deport such fraudsters, while initiating stringent possible action against them, including confiscation of passports.

Barnala senior superintendent of police Sandeep Goel said a case under Section 420 of Indian Penal Code has been registered against Beant and matter is being investigated. If role of her family members comes to fore, action will be taken accordingly, said the SSP.

Inspector Tajvir Singh of the Bilaspur police station, Rampur said, "The notice was put up according to section 82 of CrPC and the police worked according to directions received from the court. There is no role of police in his death."

Hearing the firing sound, other jawans came and took the injured jawan to hospital from where he was referred to airforce hospital in Jaisalmer, the officials said.

The reason for suicide is said to be some domestic issue. The injured jawan is married and hails from Hoshiarpur. BSF officers have started investigating the matter.

Khargone: The body of a man who jumped from a 40-foot-high Narmada bridge in Khargone, MP, has been found. He left a suicide note, which was discovered by police. Before he died, the guy recorded himself accusing his in-laws of wanting Rs 1 crore, including the divorced wife. The case is being investigated by the police. The deputy ranger's father accused the son's wife and in-laws of torturing him, citing a video taken shortly before his death. Ajay Dwivedi, the son of a deputy ranger, was discovered floating in the Narmada river near Village Muralla after jumping off the Narmada bridge in Barwah, 80 kilometres from the district headquarters.

On Thursday afternoon, Rewa resident Ajay Dwivedi was riding a scooty from Indore to Omkareshwar with his spouse. He leapt from the Narmada Bridge for this reason. Sunil Kevat and his colleagues had been on the hunt for three days. The corpse was discovered floating in the Muralla Narmada river on Saturday. The divers approached him and hauled him out, confirming Ajay Dwivedi's identity. As soon as the report was received, the deceased's family members hurried to the scene. The deceased's father, Pramod Dwivedi, wrapped himself over his son's corpse and began wailing.

The deceased was taken to the Barwah Government Hospital for a postmortem. Pramod Dwivedi, Ajay's father, is a deputy ranger in Rewa district's Sirmour. The in-laws of Ajay's son Ajay have filed a dowry harassment complaint against Ajay and us, stating that he was tortured for rupees. The son has been content as a result of this. The case is being investigated by the police.

JAISALMER: A 36-year-old man committed suicide by jumping before a moving train near Jasder Dham under Barmer rural police station.

A suicide note has been recovered which states that the reason for suicide is a domestic dispute. Meanwhile, the man's family members lodged a case against his wife for abetment to suicide.

According to the rural police, around Saturday around 8pm, when the Kalka express train was coming from Jodhpur to Barmer, the Cheetar Ka Paar resident, Magaram, committed suicide by jumping before the train between Jasder Dham and Uttarlai.

A crowd gathered after the incident and the train left after some time. Police reached the spot and kept the body at a mortuary and handed over the body to the family members after post-mortem.

Khagaria: A case of suicide has come to light in Khagaria, Bihar, where Junior Engineer of Electricity Department has committed suicide. JE, fed up with the torture of his wife, hanged himself and embraced death.

Madhya Pradesh: Son kills self on railway tracks, weeping dad hit by another train

Date: December 4, 2021

BHOPAL: A heart-rending double tragedy played out on a stretch of railway tracks in MP's Hoshangabad on Thursday midnight. A man ran away from home after a quarrel with his wife and jumped before a train. His father, running after him, sat down the tracks, numbed with shock, holding the mutilated remains of his son in his lap. Another train came and ran him over.

Police named the victims as 36-year-old Chhotelal Vishwakarma and his father [Mohanlal](#), 60, residents of Marupura Sohagpur village, around 60km from Hoshangabad and 150km from Bhopal. Both of them were carpenters. According to police, Chhotelal had a dispute with his wife, and she was living with her parents for the past few months. Late Thursday night, they again had a fight over phone after which Chhotelal ran towards the railway tracks - located 100 meters from his house - and jumped in front of an approaching train at 12.30am.

He was cut to pieces. His father, who was running after him, was beside himself with shock and grief. He gathered up some of the pieces of his son's body and sat down on the tracks, weeping, unaware of the danger.

Another train came speeding and hit him. Local residents took him to hospital, where he was pronounced dead on arrival.

Policemen went around collecting remains of Chhotelal's body till the wee hours. The GRP at Pipariya railway station has registered a case in this matter.
